Notes :

- The above financial results as reviewed by Audit Committee were taken on record by the Board of Directors at their meeting held on 29th July, 2010. The Statutory Auditors have performed a limited review as required under Clause 41 of the Listing Agreement.
- The Company is engaged in the business of manufacturing, sales and other related services of Air Conditioners. The Company is also engaged in trading of Chillers, Washing Machines and Refrigerators. However, the revenue generated from trading activity is insignificant in comparison with the total revenue, hence, segment reporting under Accounting Standard (AS) 17 in respect of such activities is not provided.
- Company predominantly operates in air conditioning business which is seasonal in nature, the first quarter results are not indicative of overall performance of the year.
- Status of Investor Complaints during the quarter: Pending at the beginning-Nil, Received-4, Resolved-4, Pending at the end of quarter-Nil.
- Operating and Other expenditure includes foreign exchange loss of Rs.398.04 Lacs on external commercial borrowings for the current quarter, whereas corresponding period exchange gain of Rs.159.01 Lacs has been included under Other income.
- Previous period figures have been regrouped, wherever necessary, to make them comparable with the figures of current period.
